### Farmington Town News: Town Hall Update –

Land for our new town hall was purchased on February 25, 2014. The Board has met with the design firm, Martenson & Eisele, and showed plans to our Planning Commission on March 24<sup>th</sup>. We are hoping to be in the new town hall in time for the November elections.

Agenda items are the audit and financial report by Chairman Trinrud followed by any other business that may legally come before the Board.

### Open Book/ Board of Review:

Each year residents are given the opportunity to meet at the Town Hall with the assessor during Open Book to discuss their current property assessments. If you choose after that meeting to appear before the Board of Review to contest your assessment, you will need to submit the necessary objection form in advance and receive an assigned appearance time from the Town Clerk. The burden of proof lies with the property holder to provide their case for change in assessment.

Open Book and Board of Review are held at the Town Hall. Specific dates published in Waupaca County Post West.

WINTER was very hard on our roads with the snow, rain, ice causing Faulks Bros. to be out and about on many occasions for snow removal and sand/salt spreading. Our expenses for the 2013-2014 winter maintenance thru March 19<sup>th</sup> is \$131,609.85. We spent \$116,575.70 during the 2012-2013 winter season.

#### Spring Clean-up:

The Waupaca HS Student volunteers will clean up debris along **King** and **Pryse** roads this spring as part of their community project. The Town also appreciates any walkers who pick up litter found in ditches. Neighbors take small plastic bags along on their walk for that reason. **Thank you.** 

Garbage Tags.....As reported in the Waupaca County Post West, December 26,2013, the Waupaca Regional Recycling & Compost Commission, at their November 21,2013 meeting, voted to increase the cost of the garbage tag form \$2 per bag to \$3 per bag. Tags are available in sheets of 5 at a cost of \$15.00 per sheet at the Town Hall.

#### **ROADS:**

The Town Board will be taking their spring road tour on April 7<sup>th</sup> to re-familiarize ourselves with suggestions made during our fall tour. At that time we found that many roads would do well with a seal coat application to help preserve their life expectancy. We also have potholes and crack sealing. The winter frost upheavals have not been kind to the roads.

The Town Board will be working with Roger Holman, Director, Waupaca County Parks and Recreation, this spring to provide safe parking on County Park Lane. We have also asked for his assistance in developing a kayak access to McCrossen Lake on our Grandview Rd. fire lane/right-of-way. Access will not allow for boat/trailer launching options.

Severe weather alert radios – that time of season....Andrew Carlin, Director, Waupaca County Emergency Management.

NOAA Weather Radio (NWR) broadcasts National Weather Service weather alerts. warnings, watches, forecasts and other hazard information 24 hours a day. Weather radios are called "indoor tornado sirens" because they broadcast tornado warnings as soon as they are issued and can wake you while sleeping. Outdoor storm sirens are meant only for warning people outdoors. They may not be heard at night or during a loud thunderstorm. All Hazards Weather Alert Radios will sound for a variety of situations, including severe weather. hurricanes, tornadoes, amber alerts and civil emergencies. Portable versions provide localized alerts to travelers, storm watchers and outdoorsmen. A weather radio that can run on back-up batteries is the only way to ensure you receive alerts even without electricity.

Weather Alert Radios are an inexpensive safety device. If you already have one, don't forget to test it. Every Wednesday around 11:00am the NWS does a test. Make sure that the volume is loud enough for you to hear. Change your battery (if it has one) when you change your clocks in the spring. The radio is also a quick way to get a local weather report at the touch of a button.

The Emergency Management Dept. at the Courthouse is available to program any weather alert radios purchased by our residents.

The Town currently oversees three cemeteries: **Barton, Salem, and Sheridan.** Sites are available for purchase at \$300.00 which includes Perpetual Care. Anyone interested can contact the Cemetery Secretary, Sandy Grenlie, at the Town Hall, 715-258-2779

## Burning Permits.....Eric Halverson, Deputy Director Waupaca County Emergency Management

When used appropriately, burning permits are an important tool in wildfire prevention. They allow the public to burn legal materials in the outdoors and are proven to be effective in protecting lives, property, and natural resources from the damages of unwanted wildfires.

# The simple steps to being a responsible debris burner:

- 1. Obtain the annual <u>burning permit online</u> or by calling 1-888-WIS-BURN (947-2876) to have a permit mailed or instantly emailed. Permits are also available at a local Ranger Station or from an <u>Emergency Fire Warden</u>.
- 2. On the day of the burn, check on the internet or over the phone after 11:00am for the daily fire restrictions in the county where you wish to burn: <a href="www.dnr.wi.gov/wisburn">www.dnr.wi.gov/wisburn</a> OR 1-888-WIS-BURN (947-2876) (enter County Code)
- 3. Follow the rules for the day. Have tools and water available, and make certain your fire is completely out before leaving.

Burning Permits, It's Your Responsibility (PDF) is a printable summary of statewide forest fire regulations and other basic fire program information.

Information you will receive: Since weather conditions can change rapidly, fire managers set fire restrictions based on the current and predicted fire danger for the day. These restrictions will tell you if burning permits are required, time, and size restrictions, or if burning has been suspended due to increased forest fire danger. Remember, you must check daily after 11 am on the day you wish to burn regardless of whether or not you are planning to burn in the ground or in a barrel.

The DNR-issued free burning permits are good for the calendar year and are non-transferable. Waupaca County requires a burning permit January 1 – May 31 (not required when the ground is completely snow-covered).

How Do I Get Rid of Old Medications?..... by Debbie Krogwold, Recycling Coordinator


The Waupaca Police Dept., 1245 S. Washington, will accept unwanted prescription and over-the-counter medications and supplements (pills, liquid, ointment, creams) Saturday, April 26 from 10am to 2pm. Keep medications in their original containers with name of medication visible. Your name can be removed or crossed off. Place liquid bottles in a sealed plastic bag. Needles and lancets cannot be accepted. Contact your pharmacy or Riverside Hospital for disposal information. If you miss this event, there is a medication drop-box at the Waupaca Sheriff's Dept. available year-round.

# What Do I Do with Old Paint, Varnish, Pesticides and other Hazardous Waste?

The Waupaca County Household Hazardous Waste Collection Program begins May 1 and runs through October 31 at the Waupaca County PTF, located at E4981 Swan Rd., Manawa. For minimal cost (\$0.20 to \$0.45 per pound), Waupaca County residents can properly dispose of oil and leadbased paint, varnish, stain, gasoline and other flammable liquids, pesticides, pool chemicals, and many other hazardous chemicals. This program is BY APPOINTMENT ONLY. To set up an appointment, please contact the PTF at 920-596-5370.
